Dear Parents,

I hope you are all keeping safe and well in this continued difficult time for many. As I said in our class newsletters on Friday, after any new government announcements I would keep you updated. On Sunday, the Prime Minister announced the new government plan for schools and further detail was provided yesterday. We heard that schools 'may open' to more pupils from the 1st of June and I am writing to inform you of our response to this announcement.

Until the 31st of May, nothing changes. The school remains open to the children of critical workers. Despite the return to work of many professions, the critical worker list remains unchanged. The Prime Minister stated that schools 'may open' from June the 1st for: children of critical workers; Nursery pupils; Reception pupils; Year 1 and Year 6. This is dependent on the 'R' rate and meeting the five tests that the government has set out. He went on to say that the rest of primary pupils 'may return' one month before the end of the summer term. This leaves parents with many questions and most importantly - how will my child be safe?

As at the beginning of lock down, we will deal in facts. The potential opening of schools to more pupils is still three weeks away which gives us time to plan. First and foremost any plans we make will be based upon the safety and well being of your child, staff and families.

Our first action is to assess risk and plan for safety. We will be carrying out the following actions over the next week:

1. Identify areas of risk associated with the new guidelines
2. Reassess our current risk assessments and adapt
3. Identify levels of safety that can be achieved
4. Identify and put in place measures to address the risk
5. Plan a reopening which meets the risk assessment requirements

Once we have assessed risk and identified the measures we can put in place we will write to you informing you of what the school opening will look like. Safety will always be the leading factor in our decisions. We have three weeks to plan and we will provide updates and information in a timely manner, where possible.
